1. Call to Order:

Mayor Douglas Jeffrey IV called the Regular Meeting of the Vernon City Commission to order at 6:30 p.m. in City Hall, and a quorum was declared present.

**ORDINANCE NO. 1731**

**AN ORDINANCE ADOPTING THE BUDGET FOR THE FISCAL YEAR OCTOBER 1, 2018, AND THROUGH SEPTEMBER 30, 2019, FOR THE CITY OF VERNON; APPROPRIATING MONEY FOR THE VARIOUS FUNDS AND PURPOSES OF SUCH BUDGETS; ESTABLISHING AND ADOPTING AN OFFICIAL CLASSIFICATION PLAN FOR ALL POSITIONS AND ABOLISHING ALL POSITIONS NOT LISTED IN SAID BUDGETS; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; REPEALING ALL ORDINANCES AND APPROPRIATIONS IN CONFLICT; DECLARING AN EMERGENCY AND PROVIDING FOR AN EFFECTIVE DATE.**

Commissioner Aydelott moved to approve Ordinance No 1731. That motion was seconded by Commissioner Ferguson.

4. Ratify Budget Ordinance 1731 which raises \$43,614.00 more revenue from taxes that the previous year (as required by H.B. No 3195, Section 102.007(c), Local Government Code)

Commissioner Ferguson moved to approve Ordinance No 1731. That motion was seconded by Commissioner Aydelott.

5. Discussion, consideration, and possible action on Ordinance No. 1732 an ordinance setting the 2018 Tax Rate

#### **ORDINANCE NO. 1732**

**AN ORDINANCE APPROVING THE 2018 TAX ROLL; LEVYING AD VALOREM TAXES ON ALL TAXABLE PROPERTY IN THE CITY OF VERNON, TEXAS, FOR THE YEAR 2018; PROVIDING FOR THE MAILING OF TAX STATEMENTS; FIXING THE DUE DATE AND TIME OF PAYMENT THEREOF, AND PROVIDING FOR THE COLLECTION OF TAXES, A SAVINGS CLAUSE, A REPEALING CLAUSE, RECORDING, DECLARING AN EMERGENCY, AND EFFECTIVE DATE.**

Commissioner Gosline made the following motion: "I move that Ordinance No. 1732 be adopted, and that the property tax rate be increased by the adoption of a tax rate of \$0.56471, which effectively increases total tax revenue by \$43,614 over last year's property tax revenue increase in the tax rate, and sets the interest and sinking fund rate of \$.171247." to approve Ordinance No 1731. That motion was seconded by Commissioner Ferguson.
