CITY EMPLOYEE TAKING INFORMATION \_\_\_\_\_

CITY OF VERNON UTILITIES ARE BILLED ONCE A MONTH. THE TIMING OF YOUR BILL DEPENDS ON YOUR ADDRESS. IF YOUR BILL IS PAID WITHIN THE 15 DAYS DUE DATE SHOWN ON THE BILL, YOU PAY THE NET AMOUNT. AFTER THE 15 DAY DUE DATE, THE GROSS AMOUNT IS DUE. ANY BILL NOT PAID IN FULL AFTER A MINIMUM OF 45 DAYS WILL RECEIVE A "FINAL NOTICE" SHOWING A DISCONNECT DATE. IF THE TOTAL DUE IS NOT PAID IN FULL BY 5:00PM ON THE DISCONNET DATE SHOWN ON THE "FINAL NOTICE", SERVICE WILL BE DISCONNECTED WITHOUT FURTHER NOTICE. IF DISCONNECTED, PAYMENT OF ALL AMOUNTS PLUS A \$25 RECONNECT FEE AND A DEPOSIT OF THREE (3) TIMES THE AVERAGE MONTHLY BILL WILL BE REQUIRED FOR RECONNECTION.

YOU CAN REQUEST THAT PERSONAL INFORMATION CONTAINED IN OUR UTILITY RECORDS NOT BE RELEASED TO UNAUTHORIZED PERSONS. The Texas Legislature has allowed publicly owned utilities to give their customers the option of making the customer's address and phone number confidential.
